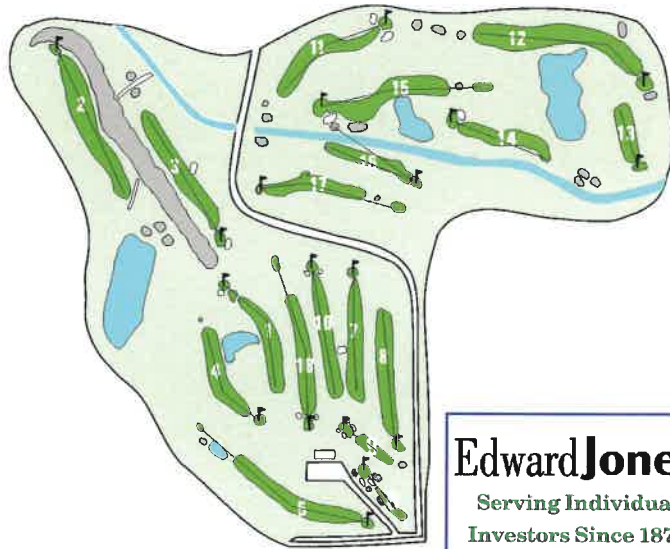
LOCAL RULES
